

## PRODUCT USE GUIDE FOR LIFT BATH AND WASHROOM CLEANER D34

### Product Description

An effective foam cleaner and descaler for light to medium soiling. Ideal for cleaning and descaling taps, baths, showers, ceramics, plastics and porcelain surfaces. Leaves rooms deodorised, sanitized, descaled and clean. Contains a fresh citrus fragrance. Suitable for all non-ferrous metals. Proven to be effective against MRSA.

### Product Features

- Formulated for frequent bath and washroom cleaning.
- An effective cleaner and descaler for light to medium soilings.
- Has passed the European Suspension Test (BSEN 1276) and has been found to be effective against the following bacteria after a contact time of 5 minutes:  
Pseudomonas Aeruginosa, Escherichia Coli, Staphylococcus Aureus, Enterococcus Hirae, Salmonella Typhimurium, Listeria Monocytogenes,
- Has passed BSEN 13727 and has been found to be effective against the following bacteria after a contact time of 5 minutes:  
Methycillin Resistant Staphylococcus Aureus (MRSA).
- This product has not been tested on animals.

### Direction for Use

- Caution – do not leave for long periods on chrome or gold plated fittings.
- Do not use on marble surfaces. Spray liberally onto surfaces, leave 2-3 minutes. Rinse clean.
- 5 Litre product can be used to refill the 750ml and 500ml foaming trigger versions of his product

### Storage

- Store in cool conditions away from direct sources of heat
- Avoid extremes of temperature
- Do not allow to freeze
- Ensure the cap is tightly fitted after use
- Keep out of reach of children

### Shelf Life

- Shelf life 24 months, if stored as recommended.
- Use within 6 months of opening.
